

ODP Clarification Regarding CPS for Individuals living in Residential Group Homes

The following question regarding CPS services to individuals who live in a group home was discussed during RCPA's IDD Division meeting today, and it was posed to the Office of Developmental Programs (ODP) earlier this week:

If a county is now in yellow and a CPS provider is ready to take individuals out for walks, etc., can individuals who live in group homes restart CPS services if their team agrees? And if so, should the group home provider bill as per prior policy – with day if the individual is out of the home for several hours, or without day if they are only out for an hour or two?

ODP's response is as follows:

The short answer is no. During yellow phase, residential providers should be supporting individuals in the community in accordance with the Individual Transition Guide team planning. This is consistent with the ISP Manual:

“Without Day”: “Licensed Residential Habilitation Without Day” (Modifier HI) is any day in which one of the following occurs:

- A participant solely receives services that are part of the Residential Habilitation service; or
- A participant receives fewer than 5 hours of services and/or unpaid supports **that are not included in the Residential Habilitation service.**

Providers cannot provide CPS for Residential Individuals because Residential providers are being reimbursed the “Without Day Program” rate.
