

Act re direct primary care

(PN 20) The Medical Service Agreement Act provides for direct primary care, medical service agreements and insurance, for medical service agreement requirements, for use of health savings accounts or flexible spending accounts, and for use of other health care practitioners. The bill establishes that in order to be considered a medical service agreement under this act, the medical service agreement shall be in writing, be signed by the patient or patient's legal representative or quardian, be signed by the physician, allow either party to terminate the medical service agreement upon written notice to the other party, describe the specific health care services that are included in the medical service agreement, specify the fee for the medical service agreement, specify the period of time under the medical service agreement, and include the following statement: This agreement does not provide comprehensive health insurance coverage. The agreement only provides for the health care services specifically described. Effective in 60 days.

Amends Titles 18, 22, 23, 42, 44, & 61

(PN 918) Amends Titles 18 (Crimes and Offenses), 22 (Detectives and Private Police), 23 (Domestic Relations), 42 (Judiciary and Judicial Procedure), 44 (Law and Justice) and 61 (Prisons and Parole, making editorial changes and related repeals. This legislation establishes the Law and Justice Code and retains current provisions relating to DNA data and testing and constables while adding and codifying three statutes; the Pennsylvania Commission on Crime and Delinquency Law, 1978 Act 274; the Deputy Sheriffs' Education and Training Act, 1984 Act 2; and the Crime Victims' Act, 1998 Act

(PN 69) Amends the Insurance Company Law, in casualty insurance, providing for billing eligible insureds for services by an out-of-network provider. The bill establishes that an out-of-network provider that renders mental health care, substance use disorder treatment or treatment for a disability to an eligible insured in this commonwealth is prohibited from billing an eligible insured for any amount in excess of the cost-sharing

amounts that would have been imposed if the mental health care, substance use disorder treatment or treatment for a disability had been rendered by an innetwork provider. Effective in 60 days.

(PN 72)Amends the Public School Code, in intermediate units, repealing provisions relating to psychological service; establishing the addition of school social workers to the definition of professional employees and providing for a definition of school social workers. Provides for the transfer of student health records to the school district where the student is newly enrolled and for the retention of health records. Establishes staffing ratios for school counselors, psychologists, social workers, and school nurses. Effective in 60 days.

Amends Title 71 re hiring and promotion auth.

(PN 82) Amends Title 71 (State Government), in civil service reform, providing for excepted service hiring and promotion authority for individuals with disabilities. This legislation enables an appointing authority to more effectively and efficiently hire and promote qualified, working-age adults, whose physical or

mental impairments impact their ability to participate in the competitive hiring and promotion process in the commonwealth's workforce. Establishes that the Office of Vocational Rehabilitation shall provide necessary supports including identifying agencies that will hire a working-age adult with a significant disability, identifying eligible candidates, developing customized employment job classifications, providing job coaching, and providing another service for a

working-age adult that is customarily provided by the Office of Vocational Rehabilitation to their similarly-situated customers. Effective in 60 days.

Amends Title 23 re parentage

(PN 83) Amends Title 23 (Domestic Relations) adding provisions relating to establishment of parent-child relationship for certain individuals; providing for voluntary acknowledgment of parentage, for registry of paternity, for genetic testing, for proceeding to adjudicate parentage, for assisted reproduction, for surrogacy agreements and for information about donors. The bill establishes that an individual is presumed to be a parent of a child if: the individual and the woman who gave birth to the child are married to each other and the child is born during the marriage, whether the marriage is or could be declared invalid; the individual and the woman who gave birth to the child were married to each other and the child is born not later than 300 days after the marriage is terminated by death, divorce, dissolution or annulment, whether the marriage is or could be declared invalid; or the individual and the woman who gave birth to the child married each other after the birth of the child, whether the marriage is or could be declared invalid, and the individual at any time asserted parentage of the child. (PN 548) Amends the Early Intervention Services System Act further providing for title of the act by changing the Department of Public Welfare to the Department of Human Services; providing for definitions of "postpartum depression," for high-risk child identification, assessment and tracking system; and making editorial changes to update obsolete cross-references and outdated terminology. (PN 174) Communicable Disease Reporting Act providing for the disclosure of communicable diseases in certain facilities during disaster emergencies. Provides for release of information upon request, confidentiality, and enforcement. Effective immediately.

Act re tattoo & body piercing standards

(PN 176) The Corrective Cosmetic Artists provides sterilization, sanitation and safety standards for any business engaged in tattooing or body piercings. Establishes that DOH shall establish a registry and adopt regulations to carry out provisions of the act. Provides for the duties and responsibilities of

artists, prohibitions for minors without written consent of a parent or legal guardian, authority of municipalities, unlawful acts, tongue-splitting limitations, disciplinary matters, penalties, injunctive relief, and exemptions. The section related to powers and duties of DOH shall take effect in two years. The section related to the tongue-splitting limitation shall take effect in 60 days. The remainder of the act shall take effect in 180 days.

Amends Drug & Alcohol Programs re drug testing

(PN 187) Amends the Administrative Code, in powers and duties of the Department of Drug and Alcohol Programs, further providing for powers and duties. The bill establishes that the standards shall require that private and public treatment and rehabilitation facilities may not deny addiction treatment to an individual solely due to a negative result on a drug test. Effective in 60 days.

An act re healthcare preauthorization

(PN 1099) Amends the Insurance Company Law, in quality health care accountability and protection, establishing standards related to preauthorization of health care services and step therapy; and making an editorial change. The legislation establishes the responsibility of managed care plans to make updates to enrollment eligibility information within 30 days of receiving updated enrollment information, provides that prior authorization requests shall be accessible to health care providers and accepted by insurers and utilization review organizations

electronically, and provides standards for preauthorization costs and for restrictions on preauthorization of health care services. The legislation provides provisions related to continuity of care, step therapy protocols, operational standards, access requirements in service areas, uniform preauthorization form and preauthorization exemptions, and data collection and reporting. Effective in 60 days.

Amends Title 65 re lobbying transparency

(PN 242) Amends Title 65 (Public Officers), in lobbying disclosure, providing provisions for the disclosure of a reportable business relationship. Requires lobbyists to provide a detailed annual report disclosing reportable business relationships if a formal or informal agreement or understanding exists in which the lobbyist or client pays, has paid, or promises compensation to a person whom the lobbyist or client knows is a state official or employee; if a nongovernmental entity has reason to know that the state official or employee has requisite involvement; or it involves a third party as directed by the state official or the entity. Provides for determining factors if a relationship is required to be reported. Further provides for the disclosure of a reportable business relation and establishes penalties. Effective in 120 days.

(PN 246) Amends Titles 23 (Domestic Relations) and 42 (Judiciary), in child protective services, establishing that child abuse includes exposing a child to alcohol or a controlled substance during pregnancy if the child has a positive test for a controlled substance or is diagnosed with fetal alcohol spectrum disorder; and, in juvenile matters, establishing like provisions related to the term "dependent child." Effective in 60 days.

(PN 251) Amends Title 18 (Crimes & Offenses), in firearms and other dangerous articles, further providing for definitions, for licenses, for sale or transfer of firearms and for Pennsylvania State Police, repealing provisions, and providing for licensing of dealers and for administrative regulations. Repeals the Pennsylvania Instant Check System and provides for criminal background and mental health checks to be conducted through the National Instant Criminal Background Check System. Effective in 360 days.

(PN 265) Amends Human Services Code, in general powers and duties of the department, providing that nondiscrimination requirements on any department or service provider under arrangement with a department for execution of programs, including the medical assistance program, awarding grants, or the provision of adequate child welfare services on the basis of race, color, familial status, religion, ancestry, age, sexual orientation, gender identity or expression, national origin, handicap or disability or use of an assistance animal. The act provides that any entity that dispenses services under an arrangement or is licensed or supervised by a department to enforce an employment nondiscrimination policy on the aforementioned grounds. Effective in 60 days.

Amends Tax Reform Code re sales tax

(PN 276) Amends the Tax Reform Code, in sale & use tax, providing for imposition of tax and for computation of tax, repealing provisions relating to exclusions from tax and for alternate imposition of tax and credits; and providing for special taxing authority. Removes all exceptions and exclusions to the Sales and Use Tax and reduces the statewide Sales and Use Tax rate from 6 percent to 1.9 percent. Section 5 of this act shall take effect immediately, and the remainder of this act shall take effect upon publication of this notice.

Act re health benefits

(PN 289) The Health Insurance Core Benefits Coverage Act provides that an insurer offering, issuing, or renewing an individual or group health insurance policy shall include federal essential health benefits. Provides an individual or group health insurance policy shall cover health benefits at least as comprehensive as the health benefits required to be covered in a policy first offered in 2020. Provides provisions related to modifications. Allows for the promulgation of regulations and temporary regulations. Provides for the act's enforcement and applicability. Repeals all acts and parts of acts inconsistent with this act. Effective immediately.

Amends School Code re derogatory terms

(PN 337) Amends the Public School Code making editorial changes removing certain terms such as "crippled", "defective", "disturbed", "handicapped" and "retarded" from the code. Also removes changes to homebound instruction and updates terminology related to intellectual disability and removes reference to "at the detention home" and the reference to "other" related to inappropriate conduct. Effective in 60 days.

Act re healthcare worker COVID-19 protections

(PN 340) The COVID-19 Pandemic Front Line Employee Health and Safety Protection Act provides requirements for health care or emergency responder employers on protecting workers from COVID-19 exposure. Provides requirements and limitations for an employer in another sector to protect

employees from COVID-19 exposure. Establishes the right to bring own personal protective equipment, duties of the Department of Health and employers regarding notification of illness in the workplace, and whistleblower protections. Permits the Department of Labor and Industry to impose civil penalties for violations. Effective immediately.

Amends Municipalities Statute re local police

(PN 355) Amends Title 53 (Municipalities Generally) adding a new subchapter establishing the Municipal Police Enhancement Consolidation Grant Program to be administered by the Pennsylvania Commission on Crime and Delinquency to provide grants to be used to improve and enhance the capabilities of municipal police departments, incentivize consolidation, and provide training and other appropriate resources to municipal police officers. Provides for publication and notice of program, award of grants, applications for grants, and accreditation or consolidation incentives. Also establishes the Municipal Police Enhancement Consolidation Grant Program Fund. Effective in 60 days.

(PN 356) Amends Title 20 (Decedents, Estates and Fiduciaries), in incapacitated persons, further providing for provisions concerning powers, duties and liabilities. The bill establishes that a guardian of the person shall have the same authority to make mental health care decisions on behalf of the incapacitated person as a mental health care agent, and a mental health care decision by the guardian of the person shall be effective without court approval as with a mental health care agent. Effective in 60 days.

Amends Crimes Statute re ammunition purchases

(PN 368) Amends Title 18 (Crimes and Offenses), in firearms and other dangerous articles, further providing for definitions, for persons not to possess, use, manufacture, control, sell or transfer firearms, for sale or transfer of firearms, for Pennsylvania State Police, for firearm sales surcharge, for Firearm Records Check Fund, for retail dealer required to be licensed and for licensing of dealers and providing for ammunition purchase authorization permits and for transporting ammunition into this commonwealth. The bill establishes that a person holding an ammunition purchase authorization permit may purchase or otherwise seek the transfer of ownership of ammunition from a retailer that sells ammunition. An ammunition purchase authorization permit shall be valid for four years from the date of issuance. Also establishes a process for the Pennsylvania State Police to approve and revoke applications for an ammunition purchase authorization permit, with a fee not to exceed \$50. In transporting ammunition into this commonwealth, the bill establishes that a resident of this commonwealth may not transport ammunition into this commonwealth if the resident purchased or otherwise obtained the ammunition from outside of this commonwealth and the ammunition has not been delivered to a licensed importer, licensed manufacturer or licensed dealer in this commonwealth for delivery to the resident. Effective July 1, 2021, or immediately, whichever is later.

(PN 378) Amends the Human Services Code, in children and youth, providing for the establishment of a statewide children's mental health ombudsman to advocate on behalf of children with mental health disorders for a term of five years for a maximum of two terms and to report to the secretary or executive director of the Governor's Office of Advocacy and Reform. The legislation provides the ombudsman with duties and reporting procedures. Effective in 90 days.

THB 433 Bradford, Matt

Act re budget bill

(PN 663) The General Appropriations Act of 2021 provides from the General Fund for the expenses of the executive, legislative and judicial departments of the commonwealth, the public debt and the public schools for the fiscal year July 1, 2021, to June 30, 2022,

and for the payment of bills incurred and remaining unpaid at the close of the fiscal year ending June 30, 2021; provides appropriations from special funds and accounts to the executive and judicial departments for the fiscal year July 1, 2021, to June 30, 2022, and for the payment of bills remaining unpaid at the close of the fiscal year ending June 30, 2021; and provides for the appropriation of federal funds to the executive and judicial departments for the fiscal year July 1, 2021, to June 30, 2022, and for the payment of bills remaining unpaid at the close of the fiscal year ending June 30, 2021. Effective July 1, 2021, or immediately, whichever is later.

MB 464 Boback, Karen

Amends Family Caregiver Support Act

(PN 1392) Amends the Family Caregiver Support Act updating the intent of the act and language, providing definitions for Alzheimer's disease or a related disorder, care receiver, older relative caregiver for a child and primary caregiver, providing for the department's authority in reimbursements. Provides that prior to making a change to the maximum amount available to a qualified primary caregiver for out-of-pocket expenses or for home modifications or assistive devices, the department shall publish a notice in The Pennsylvania Bulletin and notify the chairpersons and minority chairpersons of the Senate Aging and Youth and House Aging and Older Adult Services Committees. Further provides the department may not promulgate a regulation under this section that interferes with any privileges or rights provided by federal law. Establishes prohibitions for the primary caregiver to receive benefits under the act in the following circumstances: the primary caregiver is a perpetrator in a substantiated case of abuse, neglect, exploitation, or abandonment as defined in the Older Adults Protective Services Act, the Adult Protective Services Act, or is a perpetrator in a substantiated case of child abuse as defined

Act re Protecting Pennsylvanians

(PN 483) The Health Insurance Access Protection Act prohibits an insurer offering, issuing or renewing an individual or group health insurance policy from imposing any rule of initial or continued eligibility of any individual to enroll in or renew a health insurance policy based on any preexisting condition or health factor in relation to an individual or a dependent of the individual. Further provides for prohibition concerning premium rates; prohibition concerning beverage coverage; limitations on premium rating factors; single risk pools; regulations; and enforcement. Effective immediately.

THE 522 Isaacson, Mary

Joint Resolution re Economic Bill of Rights

(PN 486) Joint Resolution proposing separate and distinct amendments to the Constitution of the Commonwealth of Pennsylvania providing for an economic bill of rights, which includes the right to a living wage, the right to affordable health care, reliable transportation, and safe working conditions. Constitutional amendments require approval in two consecutive legislative sessions and then approval by the voters through a referendum.

Provides further provisions regarding training students on suicide awareness, violence prevention and social inclusion. Effective immediately.

Transfers the following and offices to the new department: Office of Vocational Rehabilitation; Office of Developmental Programs; Office for the Deaf and Hard of Hearing; Bureau of Blindness and Visual Services; Bureau of Disability Determination; Bureau of Early Intervention Services; and the Accessibility Advisor Board. Provides for the powers and duties of the department. Effective in one year.
