Hi Rick,

Thank you for confirming the ID/A rates will be the same across the waivers (with the exception you noted). We do have a few additional questions:

- 1. We understand that the fees are effective 10/1. When does ODP need the draft fee ranges from Mercer in order to meet the 10/1 timeline? Given the volume of services, this will take us a few weeks, but we would like to know the timelines ODP has set internally. We can then let you know how quickly we can get the draft fee ranges to you.
- 2. Will the fees be effective 10/1/21 6/30/22 (same as AAW)?
- 3. Is your expectation that, similar to AAW, there will be minimal changes to the assumptions for the other waivers except for wages and ERE?
- 4. We assume we would be using the statewide BLS wages and adjusting for the SFY 2022 Philadelphia minimum wage of \$14.25 where necessary?
- 5. Regarding your comment below for CPS, it sounds like ODP plans to implement the CPS enhanced staffing level services (i.e., W5994; W5997; W9353 and W9356) as well as CPS rates with the U1 modifier. Please confirm.

Note that we are focusing on the AAW rate refresh now and will plan for a more formal kick-off of the work for the other three waivers when the AAW work is wrapped up in the next week or so.
