

Open for Public Comment: Proposed Office of Developmental Programs' (ODP) Waiver Amendments and Rates for Select Services in Fiscal Year (FY) 2023-2024 ODP Announcement 23-043

AUDIENCE:

All Stakeholders

PURPOSE:

The purpose of this communication is to announce that the proposed amendments to the Consolidated, Person/Family Directed Support (P/FDS), Community Living, and Adult Autism Waivers and proposed rates for select services are available for public review and comment. There is a 30-day public comment period that starts on May 27, 2023 and ends on June 27, 2023 at 11:59 PM.

DISCUSSION:

ODP is pleased to announce the opportunity for public comment on proposed changes to the Consolidated, P/FDS, Community Living, and the Adult Autism Waivers. These proposed changes are scheduled to take effect November 1, 2023. ODP is also making available for public review and comment the rate setting methodology and fee schedule rates for select services in the waivers that are scheduled to take effect January 1, 2024.

Whenever substantive changes are made to an approved waiver, ODP must submit an amendment to the Centers for Medicare and Medicaid Services (CMS) for approval. As

part of this process, ODP is seeking your valuable feedback and comments on the proposed waiver amendments.

Some of the substantive proposed changes to all four waivers are as follows:

- Increase community participation for individuals receiving Community Participation Support (CPS) or Day Habilitation services and create administrative efficiencies for these services.
- Improve quality of services provided by adding provider qualification standards that address financial preparedness and experience rendering services.
- Prevent individuals from losing services due to changes in CPS or Transportation Trip rates by allowing exceptions to annual service limits in the P/FDS and Adult Autism Waivers.
- Increase employment of individuals by allowing CPS, Day Habilitation, Career Planning, and Supported Employment services to assist individuals with contacting relevant agencies and obtaining documents needed to access employment supports and services that educate participants on the impact of employment on current benefits.
- Improve quality and support provider innovation through inclusion of supplemental payments.

Some of the substantive proposed changes to the Consolidated, Community Living and P/FDS Waivers are as follows:

• Promote the health, wellness and safety of individuals receiving services by adding a Specialty Health Assessment and Coordination service.

• Support individuals with complex needs by clarifying what must be in the risk mitigation policy for Life Sharing providers when serving individuals with a medically complex condition.

Some of the substantive proposed changes to the Adult Autism Waiver (AAW) are as follows:

• Continue to allow Family Support to be delivered via teleservices when the flexibilities allowed by Appendix K expire six months after the expiration of the federal COVID-19 public health emergency.

Rates:

Additional Fee Schedule Rates are being added for:

- Group Music Therapy, Art Therapy, and Equine Assisted Therapy services provided through the Consolidated, Community Living and P/FDS Waivers.
- Needs Group 5 Residential Habilitation services provided through the Consolidated Waiver and Life Sharing Without Day services provided through the Consolidated and Community Living Waivers.

The new Specialty Health Assessment and Coordination service in the Consolidated, Community Living, and P/FDS Waivers will be reimbursed monthly as a vendor service based on the cost that the provider charges to the general public.

The rate changes proposed above are planned to become effective January 1, 2024.

In addition, ODP proposes to adopt the temporary enhanced rates for CPS and Transportation Trip as the fee schedule rates on November 1, 2023. ODP had originally planned to end these enhanced rates six months after the end of the federal COVID-19 public health emergency.
