

2023-2024 Temple Peer Review Process Beginning ODP Announcement 23-068

AUDIENCE:

Department Certified Investigators (CIs); Agency Board of Directors and Human Rights Committee Members; Agency Administrative, Management, and Risk Management Staff; Administrative Entities (AEs); Supports Coordination Organizations (SCOs); Supports Coordinators (SCs); Direct Support Professionals (DSPs); and Contracted Entities that are responsible for participating in the Peer Review process for critical incident investigations that are conducted as a requirement under the <u>Incident Management (IM) Bulletin 00-21-</u> 02 and under Chapter 6100.404 Final Incident Report.

PURPOSE:

To communicate the beginning of the 2023-2024 Peer Review process conducted by Temple University's Quality Investigations Unit (QIU), the creation of a survey to obtain updated provider information, inform providers that the Peer Review process will include the tracking of certification/recertification dates of each CI who conducted the investigation that was reviewed and inform stakeholders of staff changes within the QIU.

DISCUSSION:

2023-2024 Peer Review Cycle

Temple University will begin its 2023-2024 Peer Review process around July 24, 2023. ODP provider investigations will be selected by the QIU and the incident number for investigations will be communicated to the provider. Providers will be given an opportunity

to submit additional documentation to support the investigation under review. Once the peer reviews are completed, providers will receive a copy of the results. All Certified Investigations Peer Review (CIPR) results will be shared with ODP.

Tracking CI Certification Status

Incident Management (IM) Bulletin 00-21-02 IV (c.) Incident Management (IM) Representative states "each provider and SCO must have an IM representative ...The IM representative must ensure they:

- Maintain a list of active CIs including recertification dates;
- Manage CI roles based on quality management activities and feedback from monitoring completed by oversight entities;
- Ensuring the previous provider's staff and SCO staff's access to the Department's information management system has been removed when necessary;

To assist in the above activities, Temple University QIU tracks certification status to ensure Certified Investigators are conducting investigations within their certification dates.
