The Bureau of Family Health invites you to help influence Pennsylvania's Title V Maternal and Child Health Services Block Grant

Pennsylvania's Title V Maternal and Child Health Services Block Grant serves to improve the health and well-being of the nation's mothers, infants, children and youth, including children and youth with special health care needs, and their families. In Pennsylvania in 2022, this federal grant helped to provide services for:

- 92% of all pregnant women
- 100% of infants
- 45% of children, including 53% of children with special health care needs

The Bureau of Family Health requests your voice to help identify the seven to ten priorities that will drive Pennsylvania's Title V programs.
