#### **TOPIC: Restrictive Procedures**

A restrictive procedure is a practice that limits an individual's movement, activity, or function, interferes with an individual's ability to acquire positive reinforcement, results in loss of objects or activities an individual values, or requires an individual to engage in behavior the individual would not engage in given freedom of choice.

# **Morning Session: Program Licensure and Restrictive Procedures**

OMHSAS and ODP will discuss restrictive procedures as they relate to the licensing of Community Residential Rehabilitation (CRR) services, Inpatient Psychiatric services, Long-Term Structured Residences (LTSR), Residential Treatment Facilities for Adults (RTF-A) and Community Homes. The team will provide a compliance overview and trends found when licensing these programs.

# <u>Afternoon Session</u>: The Planning and Implementation of Restrictive Procedures

Although restraints and restrictive procedures are not ideal tools for managing dangerous behaviors, they are at times necessary to maintain health and safety. This panel presentation will review some of the strategies associated with the development of restrictive procedures, including tips for the creation of plans consistent with best practice strategies. The team will provide examples of plans that meet basic standards and discuss components that should be considered and evaluated by the Human Rights Team when reviewing restrictive procedure plans.
