ListServ Changes



What is a ListServ?

A ListServ, sometimes called a list, is a way to send information by email to subscribers.

The Office of Long-Term Living (OLTL) uses multiple ListServs to send information about our programs and activities to our stakeholders (public, providers, agencies, etc.).

ListServs are a one-way channel - messages go out from OLTL.

Stakeholders subscribe to OLTL ListServs to receive information.

While the CHC ListServ is still active for CHC-related information, OLTL has discontinued use of the MLTSS Meeting Minutes ListServ.


Archived MLTSS Subcommittee Meeting materials are still available on the ListServ Archive.

To receive LTSS Subcommittee Meeting materials in the future, please subscribe to the LTSS Meeting Minutes ListServ by following these steps:

 Click the link to the <u>LTSS Meeting Minutes Listserv</u>, which will take you to the Subscription Management page for the ListServ.





- Enter your name in the "Name" field.
- In the "Email Address" field, enter the email address where you would like to receive LTSS Meeting Minutes emails.
- Click the radio button beside either "Regular" or "Digest (Traditional)" to choose the subscription type you'd like.

*Subscription Type Differences

Subscription Type



Regular

With a regular subscription, you receive individual postings immediately as they are processed by LISTSERV.

Digest (Traditional), Digest (MIME Format), Digest (HTML Format)


With a digest subscription, you receive larger messages (called digests) at regular intervals, usually once per day or once per week. These digests are collections of individual list postings. Some lists are so active that they produce several digests per day.

Digests are a good compromise between reading everything as it is posted and feeling like the list is clogging your mailbox with a large number of individual postings.

There are three digest formats: a traditional text-only format; a MIME format, which (with mail clients that understand MIME digests) "bursts" the individual messages out of the digest so that you can read them separately; and an HTML format.



- Click the "Subscribe" button.
- The webpage will refresh to let you know that a "confirmation request was sent to your email."





- You will receive an email from the Pennsylvania Department of Human Services LISTSERV Server through the email address you submitted.
- The email will say that your request to subscribe requires confirmation. It will also say "To confirm that you want to subscribe, please click" on the link. Click the link to subscribe.
 - It could take several minutes before you receive the email. Please be patient.
 - The email also lets you know that if you don't confirm your subscription within 48 hours, the request will be automatically canceled, and you would need to repeat the process to subscribe.
