

Open for Public Comment: Proposed Waiver Amendments and Rates for Services Funded Through the Adult Autism Waiver (AAW)

PURPOSE:

To inform all interested stakeholders of the opportunity to submit public comments on the proposed amendments to the AAW effective January 1, 2025 and proposed rates for services funded through the AAW effective July 1, 2024. There is a 45-day public comment period that starts on April 20, 2024, and ends on June 4, 2024, at 11:59 PM for both the proposed waiver amendment and rates.

DISCUSSION:

The Office of Developmental Programs (ODP) is pleased to invite public comment on proposed changes to the AAW. These proposed changes are scheduled to take effect January 1, 2025. ODP is also making available for public review and comment the rate setting methodology and the fee schedule rates for services funded through the AAW and the proposed Department-established Fees for Residential Habilitation Ineligible Services that are scheduled to take effect on July 1, 2024. The Department of Human Services (Department) is required to update data used to establish fee schedule rates at least every three years. The rates for AAW services were last reviewed and updated on July 1, 2021.

Whenever substantive changes are made to an approved waiver, ODP must submit an amendment to the Centers for Medicare and Medicaid Services (CMS) for approval. As part of the amendment and rate setting process, ODP is seeking your valuable feedback and comments on both the proposed waiver amendment and rates.

INFORMATION FOR THE PROPOSED AAW AMENDMENT EFFECTIVE JANUARY 1, 2025:

Some of the substantive proposed changes to the AAW are as follows:

- Support participants who utilize American Sign Language (ASL) with the addition of an ASL English Interpreter service.
- Clarify that participants receiving services in an acute care hospital will not be disenrolled from the AAW and will not require reserved waiver capacity.
- Clarify that Day Habilitation support must include a comprehensive analysis of a
 participant's interests and preferences for community activities, skills and strengths
 likely to be valuable to employers or the community, and conditions necessary for
 successful community inclusion and/or competitive integrated employment at least
 annually.
- Clarify that Community Transition Services can be used to support individuals transitioning from settings such as Residential Habilitation to private residences in alignment with guidance in the CMS Instructions, Technical Guide and Review Criteria for 1915c waivers.
- Revisions to align waiver requirements and provider qualifications with regulatory requirements and other ODP waivers, correct errors, and provide clarification requested by stakeholders.
