navigation the document has been formatted with an interactive table of contents. Updates, clarification, and revisions <u>include but are not limited to</u>:

- The removal or revision of questions that referenced past waiver requirements and/or communications, such as the requirement to complete a variance when an individual spends more than 75% of their time each month in a facility setting.
- Additional clarification on topics such as:
 - the impacts of the HCBS Final Settings Rule on the CPS service, and
 - distinct components of the CPS service such as pre-vocational and planning and coordination.
- New questions regarding:
 - \circ $\;$ recent changes to the CPS service definition in the ID/A waivers,
 - \circ fading plans, and
 - \circ teleservices.

ODP will continue to release periodic updates to this document.
