

Now Available: Waiver Amendments for One-time Workforce Recovery Supplemental Payments Approved by the Centers for Medicare and Medicaid Services (CMS) ODP Announcement 24-041 Update

PURPOSE:

The purpose of this communication is to announce that amendments to the Consolidated, Person/Family Directed Support (P/FDS), Community Living, and Adult Autism Waivers were approved by CMS. The approved waivers are effective May 1, 2024, and are available on the Department of Human Services' (DHS) website. **Updates to the original communication are listed in Red.**

DISCUSSION:

The Office of Developmental Programs (ODP) is pleased to announce that the amendments to the Consolidated, P/FDS, Community Living, and the Adult Autism Waivers were approved by CMS on April 29, 2024. The amendments are effective May 1, 2024. As communicated in ODP announcement 24-031, the waiver amendments were submitted to CMS on March 14, 2024, for review and approval.

The Department amended the Consolidated, P/FDS, Community Living, and Adult Autism Waivers to allow providers to request a one-time supplemental payment to cover recruitment, retention, and any unusual staffing expenses resulting from the COVID-19

pandemic for direct support professionals, frontline supervisors, program specialists or Supports Coordinators. The one-time supplemental payments can be used to fund excessive overtime, shift differential incentives, costs of recruitment efforts, sign-on bonuses, retention bonuses, wage increases for Supports Coordinators, supports coordinator supervisors, direct support professionals, program specialists, and frontline supervisors, and other incentive payments. The funding is intended to allow providers to accept new participants into service. Payments may not be used to increase or supplement compensation for agency executive staff.

Providers must request the one-time supplemental payments. Payments will be calculated at 6% of fee schedule revenue received for services rendered between July 1, 2023, through December 31, 2023 for the below listed services. As of June 4, 2024 ODP has processed the subject payments for all providers who have applied. These payments should be visible on the provider's Remittance Advice on June 17th at the highest billing service location.

Payments will be calculated at 3% of revenue received for Residential Habilitation Needs Exception rates for providers that render Residential Habilitation to more than one person between July 1, 2023, through December 31, 2023.

ODP anticipates releasing Workforce Recovery Supplemental Payments in June 2024 to providers that complete the survey by May 15th. The payments will be processed in the order received. ODP will not process payments for providers that submit completed surveys after May 15, 2024.

In addition to the Workforce Recovery Supplemental Payments, ODP has also increased the number of unduplicated individuals who can be enrolled and receive services in the Consolidated Waiver by 400 individuals and the Community Living Waiver by 1,250 individuals. This increase is effective for fiscal year 2023-2024 (waiver year 2) with maintenance of the increase reflected in subsequent years.
