DISCUSSION:

I. Medication Administration Course Changes

a. Written Documentation - Part 1: Pharmacy Label/Medication Record Comparison

Written Documentation - Part 1: Pharmacy Label/Medication Record Comparison (Exam) has been revised. Part 1 is worth 15 points. The exam in Part 1 was originally comprised of 3 questions worth 5 points each. The revised Part 1 will be comprised of 5 questions worth 3 points each.

This change is being made in the Student Group course, the Student Independent course, and the Train-the-Trainer course. The change reduces the penalty for incorrectly answering a single question in this section.

This change will be enabled in new versions of the Student Group course and the Student Independent course that will go live on Monday, July 15, 2024. After this date, new users will no longer be able to be enrolled in the old student courses. However, you may continue current classes within those courses as long as users are enrolled before July 15, 2024. The new courses will automatically display on the Trainer dashboard and trainers will be able to create new group after this dates. The Train-the-Trainer course will remain the same. However, the Train-the-Trainer Course will be unavailable on Sunday, July 14, 2024 for updates to the Lesson Quizzes and Part 1 exam. The course will become available again on July 15, 2024.

b. Lesson Quizzes 1 through 9

Revisions have been made to the quiz questions at the end of each lesson. There were concerns that certain questions were confusing. Revisions in those questions should result in more clarity.
