Small Conference Room

The Small Conference Room is ideal for a small business meeting. Measuring 22' x 16', this windowless room can comfortably accommodate up to 12 people. A wall-mounted 75" monitor gives you the ability to share wireless content from any device through ScreenBeam.



RCPA Conference Center


The RCPA Conference Center is an ideal option for larger meetings. With a maximum seating capacity for 70 individuals, this room can be configured in several ways. The windowed room measures 66' x 34'.

The RCPA Conference Center is equipped with:

- > 120" projection screen
- ➤ High-definition laser projector
- Four 65" HD 4K monitors for vivid viewing of content throughout the entire room
- ScreenBeam wireless content sharing (phone, tablet, and PC)
- Video camera with pan, tilt, and zoom wide field of view
- ➤ Two 24" x 24" ceiling microphone arrays
- > Handheld wireless microphone
- ➤ Eight full range in-ceiling speaker audio system
- ➤ 16' wide x 12' deep stage with handicap accessibility
- Wireless internet (password protected)

The RCPA Conference Center can be configured in any of the following ways:

- ➤ "U" Shape = 40
- ➤ Open Square = 45
- ➤ Holiday Set = 60
- Hybrid (see Full Room View on page 4) = 60
- > Schoolroom = 64
- ➤ Theater Style = 64

- Chairs may be set up along the perimeter of the room to provide additional seating (maximum capacity of 70).
- Tables may be set up along the perimeter of the room to provide space for food, meeting materials, etc.


