NTC, Inc. President Paul DeNault explained that this grand opening is thanks to not only the staff at NTC, Inc., but also the All One Foundation, who granted NTC, Inc. the All In One Grant to help the idea come to life as well as Tina Pickett, whose legislation allows for the progression of drug and alcohol treatment.

The grand opening comes with the NTC Gym, trainers and nutritionists, among many other treatment and wellness programs to help those struggling with substance abuse.

DeNault explained that the gym, trainers and nutritionists are part of a year-long controlled study in which some individuals in treatment will be using, while others will not be, as a way for NTC, Inc. to determine the impact it has on recovery.

DeNault predicts a positive outcome, stating that he believes that, with these additions, depression and relapses will decrease, making the likelihood of recovery that much higher.

The All One Foundation's \$159,000 grant, according to DeNault, helped with "program enhancements," the hiring of specialized counselors, trainers, and nutritionists, furnishing the gym, and the purchase of computers for treatment programs.

Pickett commended NTC, Inc. and DeNault, stating that she "admires the operation" and that the work done at the facility is "immeasurable."

She also said that DeNault never has to wonder whether he is "making a difference," for those struggling with substance abuse, because he is taking a unique, creative, and helpful approach at treatment.
