



Residential Provider Pay for Performance Data Submission Tool Availability

ODP Announcement 25-019 Re-Issue

AUDIENCE:

Residential Providers

PURPOSE:

The purpose of this announcement is to inform residential providers that the link to the Pay for Performance (P4P) Data Submission Tool will be available on February 15, 2025.

This announcement is being re-issued with a correct link for the P4P survey. The link in the initial announcement was pointed to the Primary survey. The Primary survey is **NOT** the P4P Survey.

DISCUSSION:

The Residential Provider P4P Data Submission tool is web-based in QuestionPro and was created as a mechanism for providers of Residential Habilitation, Supported Living, and Life Sharing services to *voluntarily* submit data and documentation related to their organization's goals and performance in Credentialing, Technology, and Employment.

The same P4P Data Submission tool will be used for all tier categories. All responses are captured electronically via data input or document upload. Participation in each area is *optional*; providers may submit data for one, two, all three initiatives, or none. **It is recommended that Providers complete the required Performance-Based Contracting (PBC) Data Submission tool, prior to submitting for P4P, as Providers will be given the**



option in the P4P tool to use the same documents submitted for Credentialing (Primary) and Employment from the PBC tool.

Additional Details

- Providers do not need to inform the Office of Developmental Programs (ODP) of the date that they will submit data.
- Providers will submit only one Residential Provider P4P Data Submission Tool for the organization per Master Provider Index (MPI) number.
- Providers who wish to submit for P4P must submit the Residential Provider P4P Data Submission Tool by 11:59 pm on March 15, 2025.
- When the tool is submitted in QuestionPro, a printable copy of the response will show on the screen. ODP highly recommends that providers print a copy of their agency submission for their records.
