

# Performance-Based Contracting Residential Provider Data Submission Tool Availability

## **ODP Announcement 25-020**

#### **AUDIENCE:**

**Residential Providers** 

#### **PURPOSE:**

The purpose of this announcement is to inform residential providers that the link to the Performance-Based Contracting (PBC) Data Submission Tool will be available on February 15, 2025.

#### **DISCUSSION:**

The Residential Services Provider PBC Data Submission Tool is now available for all providers who did not submit PBC information in August 2024 and will instead be submitting data and documentation during the current review period (February 15 – March 15, 2025). The Data Submission tool is web-based in QuestionPro and was created as a mechanism for providers of Residential Habilitation, Supported Living and Life Sharing services to submit data and documentation related to their organization's performance. In addition to this communication, ODP will send a notification with instructions to applicable residential providers via the QA&I listserv with details for completing the PBC Data Submission Tool.

There are three separate tools, one for each tier category. Prior to accessing the webbased Residential Provider PBC Data Submission Tool, ODP strongly recommends that providers review **Appendix E** of the **Performance-Based Contracting Residential Services**

Implementation Guide which gives providers PDF versions of each tool by tier category.

Providers may only submit one Provider Submission Tool and are strongly encouraged to utilize the checklist provided in Appendix G of the Implementation Guide to determine which tool they should submit. Providers should carefully review the performance measures for each tier and apply for the tier for which the provider is likely to qualify.

Choosing the correct submission tool is important as the requirements vary depending on tier category. All responses are captured electronically via data input or document upload, and all questions must be answered within the tool.

### **Recent Updates to PBC Documents**

Based on feedback, ODP made some minor updates to the PBC documents previously published. Providers are encouraged to review the documents on the MyODP website thoroughly. A summary of the changes made, in the respective documents, is listed below.

- Data Submission Tool
  - CN-C.01.1: Repeating language from Process Details in the question prompt regarding inclusion of contractors
  - WF.03.2: Clarification that ODP is asking for full time equivalent (FTE) by requesting weekly hours instead of number of persons
  - ADM.01.1: Clarification that ODP is asking for both PA and non-PA licensing information
- Attestation: fixing typo: "to fidelity" changed to "with fidelity"
- Credentialling requirements in multiple documents: fixing typo: "goal data" changed to "goal date"
- Self-Assessment: addition of hyperlink to Incident Management Guide in the RM
   IM section
- RM IM Data: recalculation of RM-IM.01.3 using more recent data

#### **Additional Details**

- A completed <u>Residential PBC Attestation Form (fillable)</u> must be submitted with the Data Submission Tool.
- Providers do not need to inform ODP of the date that they will submit data and documentation for tier assignment.
- Providers submitting data are encouraged to review the PDF versions of the
   Data Submission Tools rather than using the live QuestionPro links to avoid any inadvertent/incomplete submissions.
- Providers will submit one Residential Provider Data Submission Tool for the organization per Master Provider Index (MPI) number.

 Providers must submit the Provider Data Submission Tool by 11:59pm on March 15, 2025. When the Provider Data Submission Tool is submitted in QuestionPro, a printable copy of the response will show on the screen.
 ODP highly recommends that providers print a copy of their agency submission for their records.
