

Listening Sessions for Renewal of the Adult Autism Waiver (AAW) effective July 1, 2026

AUDIENCE:

All interested persons

PURPOSE:

The Office of Developmental Programs (ODP) will be holding 2 webinars to give all stakeholders and interested persons the opportunity to voice ideas for updating and improving the AAW.

DISCUSSION:

The AAW is approved for a five-year period which expires on June 30, 2026. As a result, ODP is required to apply for renewal of this waiver with the Centers for Medicare and Medicaid Services (CMS).

To develop the AAW renewal, it is important for ODP to hear your ideas and suggestions for updating and improving the AAW. ODP has scheduled two webinars to give a brief overview of the waiver renewal process, with additional time reserved for your valuable input.

Registration is required for each session. Due to limited space, we ask that you only register for one session which is most pertinent to your role or involvement with the

AAW. Participation in the webinar sessions may also be by phone. When registering for the session, you must indicate that you would like to voice your ideas. To allow everyone an opportunity to provide verbal input, participants will be given a limited amount of time to provide their comments during the session. Comment time per participant will be no more than 5 minutes but could be less depending on the number of people registered.
