### **OLTL Procurement Updates**

- Procurement Updates
  - There are no updates regarding Agency with Choice (AWC) that can be shared at this time.
  - Community HealthChoices (CHC) Request for Application (RFA)
    - On August 22, 2024, the Department of Human Services (DHS) announced the applicants selected for agreement negotiations for the CHC Program Re-Procurement
    - The CHC RFA is currently in a stay. All activity pertaining to the RFA has ceased, and no timeline can be shared at this time.
    - The CHC program will continue to operate under the current Managed Care Organizations until further notice.

- Important Dates Chart, Resident Days Submission Deadlines, Penalties & Interest
  - On January 29, 2025, OLTL released the Important Dates Chart for Fiscal Year (FY) 2024-2025. This chart was also made available on the <u>Nursing Facility</u>
     <u>Assessment page of the Department of Human Services (DHS) website and the Instructions and Bulletins page of the Nursing Facility Submission System website.</u>
- Resident Days Report (RDR) Submissions
  - The deadline for submission of your RDR for the 1st & 2nd Assessment quarters for FY 2024-2025 (for the Assessment Quarter 1, April 1, 2024 June 30, 2024, and Quarter 2, July 1, 2024 September 30, 2024) is February 7, 2025.
- Penalties and Interest
  - DHS will impose a penalty for late RDR submissions in accordance with 62 P.S. § 810-A in the amount of \$1,000.00 for late submission plus \$200.00 per day until the RDRs are submitted.

- Pennsylvania Technology Summit
