May 7, 2025 Long-Term Services and Supports (LTSS) Subcommittee Meeting Follow-Up Items

<u>Dan Sharar</u>

1. Related to American Rescue Plan Act (ARPA) Funds, Ali Kronley asked what percentage of providers have reported use of the ARPA fund.

Dan Sharar, OLTL Bureau Director of Finance, responded that for Act 24 (Personal Care Homes and Nursing Facilities), they estimate about 35% of providers have reported the use of ARPA funds and, for Act 54 (All Provider Types), about 15% of providers have reported using ARPA funds.

2. Related to Assessment Fees and Provider Taxes, Matt Seeley asked about the implications of the Federal budget and how it could potentially impact provider assessment fees and access to care amounts.

Dan Sharar responded that the reconciliation bill approved by the U.S. House of Representatives on May 22, 2025, includes at least two provisions that potentially affect provider taxes – namely, prohibiting states from establishing new provider taxes or increasing rates of existing taxes and revising the conditions under which states may receive a waiver of the requirement that taxes be broad-based and uniform. Additionally, the Centers for Medicare & Medicaid Services (CMS) published a proposed rule May 13, 2025, to address CMS concerns about the methodology used to determine if a provider tax is "generally redistributive." OLTL will monitor developments on the federal budget and CMS proposed rule to determine actual impacts to Pennsylvania's assessment program.
