AUDIENCE:

- Individuals and families who are currently self-directing services or are interested in selfdirecting services through the Agency with Choice (AWC) Financial Management Services (FMS) model
- Administrative Entities (AEs)
- Supports Coordination Organizations (SCOs)
- AWC FMS organizations

PURPOSE:

To provide a list of current AWC FMS organizations available to support participants and surrogates who have chosen to self-direct some or all of their waiver-funded services using the AWC FMS model under the Consolidated, Community Living, or Person/Family Directed Support (P/FDS) waivers.

DISCUSSION:

To ensure statewide access to AWC FMS services, the Office of Developmental Programs (ODP) requires each AE to have at least one qualified AWC FMS organization available. The table at the end of this document provides a complete list of AWC FMS organizations and the areas where they

provide services across the state. If there are any updates or changes to the information in the table, the AWC or AE should notify their regional Participant Directed Services' (PDS) lead.

Note: These AWC FMS organizations should not be confused with the statewide Vendor Fiscal/Employer Agent (VF/EA) FMS organization. ODP currently contracts with Public Partnerships LLC (PPL) to provide FMS services to waiver participants who choose to self-direct their services through the VF/EA FMS model.
