DISCUSSION:

This is a reminder that the Department required that staff who took the Modified

Course in lieu of the Standard Course complete the Standard Course no later than June

20, 2023. If it has been a year or longer since the staff person completed the Annual

Practicum requirements to be allowed to administer medications, the staff person must successfully complete the entire Medication Administration Training Course, handwashing, and gloving demonstration, and four medication administration observations to be qualified to administer medications.
