IM4Q News

2025-2026 Cycle

- <u>State Budget/IM4Q Allocations</u>: The impasse prevents ODP from providing funding for IM4Q at this
 point. ODP fiscal staff will not issue allocation letters to the AEs until the budget has been passed, nor
 will ODP issue the IM4Q survey allocation spreadsheet until that time.
- Samples: Following multiple requests from local programs requesting the samples to begin
 preparations for when they could begin contacting individuals and scheduling interviews, ODP Central
 Office was granted permission to release the samples, and IM4Q regional leads have been instructed
 to distribute the samples, along with the instructions, to their AEs. If an AE has not received its
 sample by 10.31, please contact your regional lead. Reminder: This is not ODP sanctioning the
 scheduling and completion of interviews prior to having a budget. Local programs and AEs need to
 have those discussions individually.
- <u>Survey Instruments and Additional Cycle Materials</u>: the 2025-2026 survey instruments were issued to local programs and AEs on 8/14. The additional materials for the cycle will be issued during the first week of November. All will be posted to the IM4Q Team Member Resource page on MyODP within the next couple of weeks.

IM4Q Statewide Steering Committee Seeks New Members*

2025-2026 External Evaluation

DATA ENTRY

HCSIS and ODESA Cycles

- <u>HCSIS</u>: the request to open the 2025-26 cycle will be submitted during the first week of November. As with last year, the combined sample list will also be provided to indicate who should have presurveys marked as already finalized so that local programs will only need to add considerations.
- <u>ODESA</u>: ODP and the technical advisors met with HSRI and Mutually Human, who is the vendor building the ODESA 2.0 customizations needed for Pennsylvania, to officially begin the project. Everyone was eager to get started and committed to staying on schedule to open ODESA in mid- to late January.

TRAINING

Mandatory Online Deaf Services Training Reminder

All new local program coordinators and monitors are required to take the updated <u>ODP Deaf Services</u> <u>Training</u> on MyODP. Returning coordinators and monitors may retake the training as a refresher if needed. This training has replaced the *Harry M.* training that had previously been required.

New Monitor Mandatory Online NCI Training Change

In response to feedback received from states, the Human Services Research Institute (HSRI) has revised the mandatory online NCI training for new monitors and reduced it from six hours to two hours. Local program coordinators who have new monitors should contact Mary Kay Cunningham with names and email addresses so that she can register them on the platform. In addition, local program coordinators are also expected to take the training so that they are familiar with it and can answer questions from their monitors.
