OLTL Procurement Updates

- Procurement Updates
 - Community HealthChoices (CHC) Request for Applications (RFA)
 - On August 22, 2024, the Department of Human Services (DHS) announced the applicants selected for agreement negotiations for the CHC Program Re-Procurement.
 - The CHC RFA is currently in a stay. All activity pertaining to the RFA has ceased, and no timeline can be shared at this time.
 - The CHC program will continue to operate under the current CHC-Managed Care Organizations (MCOs) and agreements until further notice.

Participant Self Directed Fee Schedules

- The Fiscal Year (FY) 2025-26 budget, signed into law on November 12, 2025, included a \$21 million investment to strengthen the workforce through increased wages for direct care workers providing services in the Participant Directed Model for OLTL Programs.
 - This additional funding provides for a rate increase in the OBRA Waiver and Act 150 Program for Participant Directed (Consumer) Personal Assistance Services procedure codes W1792 and W1792 TU, effective January 1, 2026.
 - OLTL released a ListServ on December 19, 2025, notifying Waiver Providers and Service Coordinators of the rate changes impacting PROMISe™ the claims processing, provider enrollment, and user management information system, and the Home and Community Services Information System (HCSIS).

Participant Self Directed Fee Schedules cont.

- OLTL will be providing the Common Law Employers (CLEs) in the Fee for Service program an automatic Opt-In to an hourly rate increase.
 - The CHC-MCOs have indicated they will also utilize this approach.
- CLEs will not have to do anything for their employees to receive up to the 9.09% percentage increase, minus required costs related to employer costs, indicated by the change in the Medicaid Fee for Service Schedule that will be publicly posted in the PA bulletin at a later date.
- CLEs will have through the end of January 2026 to indicate other preferences before the automatic Opt-In is applied retroactively to the January 1, 2026, effective date.

Participant Self Directed Fee Schedules cont.


- As a reminder, CLEs always have the ability to set employee wages in the Participant Directed program.

CMS Rural Health Awards

- On December 29, 2025, CMS announced via press release that all 50 states will receive awards under the Rural Health Transformation Program (RHTP), a \$50 billion initiative to strengthen and modernize health care in rural communities across the country.
 - In 2026, states will receive first-year awards from CMS averaging \$200 million within a range of \$147 million to \$281 million. **Pennsylvania was awarded \$193,294,054.**
 - This federal investment will help states expand access to care in rural communities, strengthen the rural health workforce, modernize rural facilities and technology, and support innovative models that bring high-quality, dependable care closer to home.
 - The RHTP's funds will be allocated over five years, from 2026 through 2030.
