Dementia in Adults with IDD and Down Syndrome: What to Look for at the Primary Care Visit

Adults with intellectual and developmental disabilities (IDD), particularly individuals with Down syndrome, are at increased risk for earlier-onset dementia with atypical presentations. This one-hour educational activity prepares primary care clinicians to recognize early signs of dementia, distinguish lifelong baseline from new decline, and determine appropriate evaluation and referral within the primary care setting.

Diagnosis and Management of Dementia in Adults with IDD

Diagnosing dementia in adults with intellectual and developmental disabilities (IDD) presents unique clinical challenges that can lead to under-recognition or delayed diagnosis. This one-hour educational activity equips primary care clinicians with a structured, IDD-informed diagnostic approach, including how to adapt standard dementia evaluations, identify reversible conditions that mimic dementia, and assess likely dementia etiology. Participants will gain practical guidance on avoiding common diagnostic pitfalls and determining when specialty referral is indicated.
